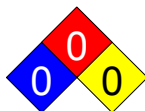

Do not attempt to adjust, repair or in any other way modify the cylinders containing this gas mixture. If there is a malfunction or another type of operational problem, contact nearest distributor.

· **Information about protection against explosions and fires:**

Pressurized container: protect from sunlight and do not expose to temperatures exceeding 50 °C, i.e. electric lights. Do not pierce or burn, even after use.

Do not cut, grind or weld on container that contains or contained product.

Do not spray on a naked flame or any incandescent material.
